**5. Reservation of posts:**

- b. The post for the reserved category candidates will be filled in by the same category candidates (Domicile of State of Maharashtra) belonging to that particular category only.
- c. Candidates belonging to the reserved category must submit a Caste Certificate and Caste Validity Certificate issued by a competent authority, the Government of Maharashtra. Additionally, the Non-Creamy Layer Certificate in the case of VJ(A), NT(B), NT(C), NT(D), SBC and OBC Category candidates need to attach along with their application. **(D)** SLET/SET score shall be valid for appointment in respective State Universities/ Colleges/Institutions only.
