Notification for Admissions against Institute Vacancy Round-3 for vacant seats of First Year Post SSC Diploma after Institute Vacancy Round-2 at VJTI. (2023-24)

As per the Rule No. 13 (Page No. 43) of Information Brochure Diploma Admissions 2023-24. The institute shall carry out the admissions for these seats in the following manner. -

- 1. Admissions shall be made in a transparent manner and strictly as per the Inter-Se- Merit of the Candidates who have applied to Competent Authority (DTE) and then to the Institution (VJTI).
- **2.** Institution shall invite applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement on the website of the institution.
- **3.** Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the competent authority (DTE), from time to time, shall apply
  - a. First to DTE Admission Cell
  - b. Then to the director of the institution (VJTI) on the given Google form.
- **4.** The institution, after verification of all required documents, shall display the Inter- Se-Merit lists of the Candidates to be filled in at the institution level.
- **5.** \*If any CAP seat remains or becomes vacant after the CAP Rounds then the same shall be filled in by the Candidate from the same Category for which it was

earmarked during the CAP. Further if the seats remain vacant then the seats shall be filled on the basis of Inter-Se-Merit of the applicants.

- 6. OMS candidates are not allowed to participate in Institute level Round of Govt. and Govt. aided Institutes.
- 7. Candidates admitted through Institute level admissions are eligible for the scholarships as per the Government of India Guide lines issued time to time.
