Item 1: Confirmation of minutes of the 46th BoG meeting held on February 10, 2017

Minutes of 46<sup>th</sup> BoG meeting held on February 10, 2017 were confirmed.

Item 2: Action taken by Director on minutes of the 46<sup>th</sup> BoG meeting held on February 10, 2017

BoG noted the action taken on minutes of 46<sup>th</sup> BoG meeting held on February 10, 2017.

The issue of alumni contribution came for discussion and the following suggestions were given by the members:

Dr. V.N. Gupchup suggested that Alumni association should start chapter outside India in USA, Australia etc. and should organize alumni meets outside India with participation of Institute authorities to make them aware of the projects undertaken by the Institute where alumni can contribute.

Dr. D.B. Phatak suggested that the institute should not ignore trickle contributions, and should be proactive in acknowledging the contributions by putting on institute's web site the details of utilization of contributions, this will help in encouraging a feeling of belongingness and better connect with past students. He has also suggested that every faculty member be asked to submit project proposal in his/her area along with financial requirements, these proposals then can be put up to alumni for funding.

Dr. R D Daruwala suggested that Alumni Association should make efforts to get 501 (C) tax exempt status for the proposed Chapter in USA. He further informed that many industries / corporations in USA provide matching contributions when their employees make donations to causes like education, research, scholarship etc. and intimate their employers.

Mr. Umesh Gupta responded to the suggestion given by Dr. Gupchup briefing the board about starting an international chapter of alumni association. He also informed that process to get tax exemption under 501 (C) is in progress.

BoG resolved that institute should prepare an action plan taking into account the suggestions given by the members to establish better connect with alumni

BoG took on record the minutes of meeting of Finance committee held on 21st and 27th March 2017.
