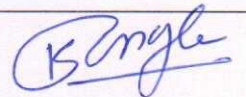

<b>Item No 1</b>	<b>Confirmation of minutes of 9<sup>th</sup> Academic Council meeting held on April 25, 2017</b>
Minutes of 9 <sup>th</sup> Meeting of Academic Council held on April 25, 2017 were confirmed.	

<b>Item No 2</b>	<b>Ratification of approval for Academic Calendar of First term of Academic Year 2017-18</b>
Academic Council ratified the approval given by Chairman Academic Council for Academic Calendar of first term of Academic Year 2017-18. It is also resolved to extend the term by two weeks for First Year of Undergraduate and Postgraduate Programs and accordingly postpone the dates of In-Semester Tests for them.	

<b>Item No 3</b>	<b>Improving Teaching Learning Resources and Processes</b>
<p><b>A) Recruitment drive for appointment of permanent faculty on vacant positions.</b>  After deliberation and discussions, Academic Council recommended following course of action.</p> <ul style="list-style-type: none"> <li>- Institute shall strive to fill vacant positions and recruit well qualified faculty members. Institute shall follow-up with State Government of Maharashtra for getting faculty positions approved for Electronics and Telecommunication Discipline.</li> <li>- Institute shall develop mechanism for appointing faculty on tenure based by creating additional faculty positions that shall be paid through Institute fund.</li> <li>- On campus accommodation/residence facilities for faculty should be created at the earliest to boost faculty-student interactions beyond office hours and to attract quality faculty (new recruitment) to VJTI from all over India.</li> </ul> <p><b>B) Improvement in numbers of quality publications, research funding, Ph.D qualified faculty members.</b>  After deliberation and discussions, Academic Council recommended to implement the process of self declaration by faculty on past and future plans for R&amp;D and teaching at the beginning of Academic Year.</p> <p><b>C) Internship for Undergraduate and Post graduate students within Institute.</b>  Academic Council principally approved the proposal of U.G and P.G students of VJTI doing Internship within Institute and a stipend of Rs 10000 per student/groups/summer. Appropriate mechanism shall be decided to select the students per discipline/program.</p> <p><b>D) Engagement of students beyond working hours.</b>  Academic Council noted the provisions made by the Institute such as extended timings for Library, Canteen facilities and Internet laboratory etc. to increase the engagement of students beyond working hours.</p>

**E) Schedule for Training and Placement activities on weekends, holidays and beyond working hours.**

The Academic Council is appraised about the Training and Placement activities in VJTI. In order to streamline the teaching learning process, Academic Council approved the schedule of Training and Placement activities only on Thursday, Friday, Saturday, Sunday and beyond working hours; leaving Monday/Tuesday/Wednesday for non-disturbed activities.

**F) Proposal for starting foreign language classes during evening/weekends.**

Academic Council approved the proposal to conduct foreign language classes on evening /weekends. Academic Council recommended to devise a mechanism for implementation.

**Item No 4 Expanding and Strengthening Ph.D Programs**

**A) Recognition as Ph.D Guide to Ph.D qualified faculty members of VJTI Mumbai appointed in Under Graduate, Post Graduate and Diploma programs of the Institute.**

After deliberation and discussions, Academic Council recommended the recognition as Ph.D Guide to the all Ph.D qualified faculty members appointed in the Institute on UG, Diploma and PG programs subject to fulfillment of requirements of Ph.D Guide of University of Mumbai.

**B) Information of Ph.D admission for Academic Year 2017-18 and stipend to full time Ph.D Scholars.**

Academic Council took on the record the list of candidates provisionally admitted for Ph.D Program in academic year 2017-18 and resolved to offer suitable stipend as per Institute budget provisions.

**C) Proposal for starting Ph.D Programs in Computer Application, Basic Sciences, Mathematics and Humanities and Social Science disciplines, inclusion of IT in CSE and EXTC in Electronics.**

After deliberation and discussions, Academic Council recommended to start new Ph.D Programs in Computer Application, Basic Sciences, Mathematics and Humanities and Social Science disciplines, inclusion of IT in CSE and EXTC in Electronics subject to fulfillment of requirements of University of Mumbai.

**Item No 5 Revisiting In-Semester Evaluation, Re-examination, and Summer Term provisions**

**A) In-Semester Evaluation:**

Academic Council approved the following revised evaluation scheme for UG and PG Program from Academic Year 2017-18 with provision of make- up test for the students those who fail to appear for MST due to medical and other valid reasons.

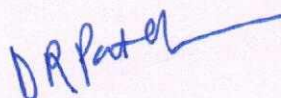
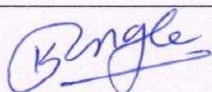

**A) Credit Courses for Ph.D and M.Tech student**

Academic Council approved the following proposal of course credit requirements for Ph.D and M.Tech Candidates:

- Internal faculty members registered for Ph.D Program may be allowed to register for MOOC



credit courses (credits  $\geq 3$ ) offered by IIT/Stanford University/ MIT university, NPTEL, SWAYAM (MHRDA) etc. These courses will be recommended by the supervisor(s) based on the research problem and subsequently approved by the Dean Academic/Director.

- Internal faculty members registered for Ph.D Program may be allowed to register for computational methods and research methodology offered by other departments of the Institute. Name of the Department will be recommended by the supervisor(s) and subsequently approved by the Dean Academic/Director.
- Internal faculty members who have already acquired requisite Ph.D course credits at IIT, NIT etc prior to admission to Ph.D program at VJTI may be considered as fulfilled credit requirements. They are required to do one suitable MOOC course in consultation with Supervisor.

**B) Application of Mr. Kamble Prashant (Roll No 122030062) for Readmission to first year**

Request of the Mr. Kamble Prashant was discussed in the meeting. Academic Council Noted that the Student was admitted in Academic Year 2013-14 and not cleared first year till A.Y 2016-17. Academic Council is in opinion that if student is permitted to appear for exams to first year courses in academic year 2017-18, he will not be able to complete the program in eight years and therefore recommended not to allow the student to continue.

**C) Extension to M.Tech and Ph.D students who completed the duration of program.**

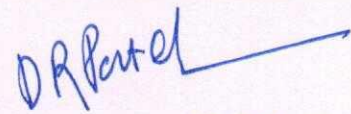
Issue of M.Tech and Ph.D student's regarding extension to complete the program after completion of duration of program was discussed in the meeting. Academic Council authorized Chairman, Academic Council, to approve the extension of M.Tech and Ph.D students to complete the program after recommendation of Departmental Advisory Committee/ Supervisor/s and Head of Department.

**D) Permission to Ph.D Candidates for satisfying the requirement of minimum CPI of 6.0 in second year of admission.**

Issue of Ph.D student's who have not satisfied the requirement of minimum CPI of 6.0 in first year of admission was discussed in the meeting. Academic Council authorized Chairman, Academic Council, to allow such student's to register for course/s in second year of program to satisfy the requirement of minimum CPI of 6.0 after recommendation of Departmental Advisory Committee/ Supervisor/s and Head of Department.
