- 2. Students belonging to reserved categories (SC/ST/PWD/VJNT/OBC/SBC/EWS/SEBC)
- a. [\*] means fees to be reimbursed from State/Central Government as free ship/Scholarship for which student's has to apply to Government in stipulate time period on MAHADBT portal.
- b. It is the sole responsibility of the student to apply (online/offline) for the free ship/scholarship to the appropriate scholarship authority (State/ Central government). If the student does not apply to the authorities for reimbursement of fees, then he/she will have to pay full fees as applicable to the Open category students.
- C. In case, if the Government for any reason decides not to reimburse the fees to the reserved category student, then he/she will have to pay the difference in fee as mentioned in column No 3., within three weeks of receipt of such information from MAHADBT portal on email/message to the individual student.
- d.
