


	<p>Financial Bid (weightage 50%)</p> <p>Total Sum of Item given in tender document with respect to Base Rate is Rs. 4278/-</p> <p>For evaluation of financial bid the following formula will be used:</p> $\text{Financial Bid marks} = 50 \times \left(1 - \frac{(L2-L1)}{L1}\right)$ <p>Let's suppose an L1 bidder quotes Rs 3700/- then he would be awarded 50 marks. Subsequently, if the quote of the L2 bidder is Rs 3800/- then the financial bid marks of the L2 bidder shall be 48.65 (i.e. 50(1- 0.0270)).</p>
2.	<p>The contractor obtaining maximum marks (out of 100) as per the following formula will be considered for the award of the contract.</p> <p>Total marks = Technical Bid Marks + Financial Bid marks</p>
3.	<p>Corrections in "General Terms & Condition of Tender, Point No 5: Deposit, Page no. 8.</p> <p>The Crockery, Cutlery, Utensils and any Other Equipment will not be provided by the Institute.</p>
