Item No 2	Matters Related to Academic Affairs
A) Discussion on Result Analysis of Academic year 2022-23	
<p>The Associate Dean, Academic Programme presented the result analysis of the academic year 2022-23 and the performance data of all final-year students of B.Tech, M.Tech, and MCA programs. The analysis included statistics such as passing percentage, number of students passing without any backlog, CPI histogram, average CPI etc.</p> <p>The Academic Council resolved that it is necessary to conduct the session on “Relative Grading” to faculty members at the beginning of each academic year.</p>	
B) Award of 10 Grace Marks/Credits to NCC cadets as per University Circular No. UG/112 of 2015.	
<p>Awarding 10 grace marks/credits to NCC (National Cadet Corps) cadets was discussed in accordance with University Circular No. UG/112 of 2015;</p> <p>The Dean of Academics a briefed the members about the guidelines outlined in the Mumbai University circular. According to the circular, students who have enrolled as members of the N.C.C and have satisfactorily completed the N.C.C. training programme during the academic year, as certified by the Principal, Associates N.C.C. Officer of their respective College are eligible to receive</p>	



10 grace marks and, in the Choice, Based Grading System (CBGS), 0.1 credits added to the final grade to Cumulative Performance Index (CPI).

The Academic Council resolved that provision mentioned in the Mumbai University Circular in this regard will be followed as it is.

C) Proposal to use 60-40 scheme to all Mandatory Non Credit Courses (MNC) courses in Sem III and Sem IV of B.Tech

To bring the uniformity across the Institute in evaluation of Mandatory Non-Credit Courses, it is proposed to implement 60 (In-Semester):40(End Semester) evaluation scheme for all Mandatory Non-Credit (MNC) courses in Semester III and Semester IV of the B.Tech program.

A. Name change of M.Tech (NIMS) to M.Tech (AI & DS)

Head of the Computer Engineering & IT Department proposed to change the name of the M.Tech program currently titled "M.Tech Network Infrastructure Management Systems (NIMS)" to "M.Tech Artificial Intelligence & Data Science (AI&DS)." He has also presented the rationale and necessity behind the proposed name change.

The Academic Council approved the change in name of the programme from "M.Tech Network Infrastructure Management Systems (NIMS)" to "M.Tech Artificial Intelligence & Data Science (AI&DS)."

It is also resolved that Head Computer and IT Department will prepare the eligibility criteria for the admission in the programme in line with guidelines given by AICTE and other statutory Bodies.

B. Extension to M.Tech student who have completed 3 year :

The Dean of Academics presented a report regarding M.Tech and MCA students who were unable to complete their programs within the stipulated time period. The respective Departmental Academic Committees (DACs) had reviewed extension requests from these students and recommended them for approval by the Academic Council.



The Academic Council approved the extension of additional one- year for the students listed in Annexure-I. Academic Council also resolved that such a students have to pay the full fees for all years starting from his/her admission in the Institute.

Item No 3	Matters Related to Ph.D. Affairs

A. Approving Dr. T. V. Sreekumar, Director of BTRA as Co-guide for Ph.D. candidates:

The Head of Textile Department proposed to appoint Dr. T. V. Sreekumar, Director of BTRA as a co-guide for Ph.D. candidates. The proposal included details about Dr. Sreekumar's qualifications, expertise, and relevance to the research areas of the Ph.D. candidates.

The academic council approved Dr. T. V. Sreekumar, Director of BTRA as a co-guide for Ph.D. candidate in the Textile Technology discipline.

The Academic Council further resolved that all faculty members who have earned and will earn their Ph.D during the service in VJTI, will be considered as Ph.D guide from the next Academic Year after award of their Ph.D Degree. It is also resolved that All the faculty members having Ph.D degree and Joining the Institute Prior to the Ph.D admission of AY 2024-25 will be considered as Ph.D guide in their respective discipline.

B. Extension to Ph.D. students who completed six/eight years duration of program:

Ph.D. students who had exceeded the stipulated time period for completing their programs have requested extensions, which were reviewed and recommended for approval by the respective Departmental Academic Committees (DACs) and the Ph.D. Affairs Committee. The list of students is available in Annexure-II.

The Academic Council approved the extension of additional one year (till A.Y 2024-25) for the students to complete their Ph.D. programs. This extension will be the last extension for the candidates who have completed more than eight years.

Additionally, the Academic Council made following resolutions related to the Ph.D candidates.

1. All students who have requested for extension have to pay the full fees applicable at the time admission for all years starting from his/her admission in the Institute.

2. If student is not able to complete the Ph.D work during one year extension the student will be terminated from the Ph.D programme.

3. Those students who have not given last two APS shall be issued termination letters.

C. Discontinuation of Ph.D. Admission of students as per recommendation of Ph.D. Affairs Committee

The issue of discontinuing the Ph.D. admission of certain students was discussed based on the recommendation of the respective Departmental Academic Committees (DACs) and the Ph.D. Affairs Committee.

Following thorough deliberation, the Academic Council resolved to discontinue the Ph.D. admission of the students mentioned in Annexure-III.
