(Sem I and Sem II combined) are **eligible** for **Institute level Branch Transfer**. Additionally, the students admitted under Supernumerary Quota (TFWS, J & K, JKSSS, PMSSS, FN, PIO, CIWGC, EWS, GOI, FNNEUT, NRI, PIO/OCI etc.) seats are not eligible for branch transfer.
