Subject: Scholarship (for B. Tech.- Mechanical Engineering) provided by SNNJ Charitable Trust & VJTI Alumni Association

This **notice** is being released for inviting applications from students of 1st to final year of B.Tech and 1st to 3rd year of Diploma course in **Mechanical Engineering** branch studying during the AY 2026-27. This is 13th year since the scholarship was introduced by the trust.

This is awarded every academic year to one student per class of each course year. The Scholarship amounts to full re-imbursement of total fees applicable (as per VJTI circular) to the respective candidate & for the respective academic year.

I) Eligibility criteria:

A) Family Economic Status:

- Total family income should be as per the definition & norms of "Economically Weaker Section" (EWS), as declared by Govt. of India or Govt. of Maharashtra that may be prevailing or in force for the current academic year.

B) Academic Scholastic Performance & Consistency:

- **B. Tech Course:** Second (SY), Third (TY) and Fourth (Final year) students must have overall **CPI** of minimum **7.5 or higher** by end of even semester of the previous year.
(Just in case; two or multiple candidates get short listed in final round, the inconsistent performer candidates with ODD semester CPI score lower than 7.5 may be dropped.)
 - First year students must have first class in Class X/XII & overall percentile score in the qualifying CET examination should be minimum of **75 or higher**.
 - Direct Second Year students must have minimum of 75 % (or 75 percentile) in the qualifying Diploma examination.
- **Exceptions:** This minimum scholastic eligibility criteria, may be lowered in specific exceptional cases or orphans (both parents of the candidate are not alive) or mentally or physically challenged candidates.

C) One Student – One Scholarship:

- The candidate should not be receiving any other scholarship for the same academic year. (Financial Aid or any other scholarship from multiple sources, by same candidate is strictly not allowed).

- Eligible and interested students desirous to apply are required to take a print out of 'application form'.

- Please note that the application form "file name" should be **re-named** as per the naming convention mentioned at the start of the application. Ensure that the File naming format be strictly followed, before submission.
- Applications submitted without following the file naming format will stand rejected.

- A) The short-listed candidates may be called for online VC Interview as per mutually convenient time schedule, fixed in advance.
