The Candidates shall carry the original documents for scrutiny & verification at identified Facilitation Centre as per the process specified by the competent authority. The candidates are required to scan the document in .jpg or .gif format (minimum 150 dpi resolution, file size upto 1 MB) and upload the scanned copies of the required documents at the time of filling up Application Form for Admission. The Facilitation Center shall assist the candidate, free of cost, to scan and upload the documents.

2. Students belonging to reserved categories (SC/ST/PWD/VJNT/OBC/SBC/EWS/Minority)
  - a. [\*] means fees to be reimbursed from State/Central Government as freeship/Scholarship for which student's has to apply to Government in stipulate time period on MAHADBT portal.
  - b. It is the sole responsibility of the student to apply (online/offline) for the freeship/scholarship to the appropriate scholarship authority (State/ Central government). If the student does not apply to the authorities for reimbursement of fees, then he/she will have to pay full fees as applicable to the Open category students.
  - c. In case, if the Government for any reason decides not to reimburse the fees to the reserved category student, then he/she will have to pay the difference in fee as mentioned in column No 3., within three weeks of receipt of such information from MAHADBT portal on email/message to the individual student.
  - d. Students are advised to visit VJTI website and also contact scholarship section of the Institute (Land Line No 022-24198104) for information related to the various scholarships and deadlines for applying to various freeship/scholarship.
3. These fees are applicable to the students admitted through CAP (Central Admission Process) rounds only.
