- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. In respect of the programmes which have been granted provisional accreditation for 2 years, Veermata Jijabai Technological Institute, Mumbai, Maharashtra should submit the Self Assessment Report alongwith a compliance report at least after 1 year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendation of EEAC will be considered by the Sub-Committee of the Academic Advisory Committee of Engineering for decision.
- 5. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Veermata Jijabai Technological Institute, Mumbai, Maharashtra as a whole. As such the institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the programme(s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
